† The Approx. Total Cost of the program is based on tuition charged per credit hour or per quarter, (average 11 weeks per quarter with a few exceptions), multiplied by the total number of credits or quarters, graduation fee, digital textbook and program fees described in the other footnotes. Actual total costs may be different depending on the total number of credit hours attempted and quarters attended.

Due to certain state requirements, the program curriculum may vary. Please contact an admissions representative prior to enrollment for program details.

A digital textbook will be provided for applicable courses and will be automatically secured through South university's contracted third-party vendor. The student cost for digital textbooks will be charged to the student account in addition to tuition. The student cost is \$10 per credit hour and for the Doctorate of Ministry program, the student cost is \$400 per quarter for the first six (6) quarters for a customized South University Logos package. The customized South University Logos package is not refundable on or after the first day of classes. For students opting out of the digital textbook, the associated charge will be reversed on the student account after the Drop/Add Period. Not all courses include a Digital Textbook. Courses that include a Digital Textbook will be noted in the registration material. Students who do not opt out will not need to purchase print textbooks for courses using a Digital Textbook. The purchase of the Digital Textbook is not refundable. Students who do opt out will be responsible for purchasing the required textbook. If a course does not use a Digital Textbook, the student is responsible for purchasing the required textbook.

Students may be required to take additional clinical hours based on previously completed Master of Science in Nursing degree clinical hours.

The Master of Science in Physician Assistant program includes a \$50 application fee, \$80 clinical tracking fees, \$200 background check, and \$75 one-time membership fee for the American Academy of Physician Assistants in Program Fees. Excluded from the Approx. Total Cost is a non-refundable \$500 acceptance fee, \$60 optional state association fees, professional instruments (approximately \$1,000), surgical scrubs (approximately \$40/set), and a laptop computer with wireless access (approximately \$1,500). The acceptance fee will be applied to the student's first quarter tuition payment. If an applicant accepted into the Physician Assistant program encounters circumstances that prevent their matriculation, any amount paid by the applicant that is above the nonrefundable application fee and acceptance fee will be refunded.

The Associate of Science in Physical Therapist Assistant program includes a \$55 Test of Essential Academic Skills V (TEAS V) testing fee in the Program Fees.

Students in the Associate of Science or Associate of Applied Science in Physical Therapist Assistant who are required to take ENG0099 and/or MAT099 will be required to take UVC1000. Students required to take UVC1000 will complete 114 credit hours of work for their degree.

The Master of Medical Science (MMSc) in Anesthesia Science includes a \$50 application fee. Excluded from the Approx. Total Cost are a non-refundable \$500 acceptance fee and professional instruments such as stethoscope (approximately \$100) and surgical scrubs (approximately \$35/set) that students may already have or purchase elsewhere. The acceptance fee will be applied to the student's first quarter tuition payment. If an applicant accepted into the Anesthesia Science program encounters circumstances that prevent their matriculation, any amount paid by the applicant that is above the nonrefundable application fee and acceptance fee will be refunded.

The Doctor of Pharmacy program has a \$50 application fee charged by PharmCas included in the Program Fees and a \$1,000 non-refundable acceptance fee excluded from the Approx. Total Cost. The acceptance fee will be applied to the student's first quarter tuition payment. If an applicant accepted into the Pharmacy program encounters circumstances that prevent their matriculation, any amount paid by the applicant that is above the nonrefundable application fee and acceptance fee will be refunded.

Students applying to the RN to BSN program, who have earned an Associate's degree in nursing from an acceptable accredited institution, may receive up to 90 transfer of credits for the General Education and Foundation course requirements.

The Master of Science in Nursing with a specialization in Family Nurse Practitioner (RN to MSN) program has \$2,625 practicum evaluation fee (5 practicum courses at \$525 per course) included in the program fee estimate. Students applying to the RN to MSN Programs, who have earned an Associate's degree in nursing from an acceptable accredited institution, may receive up to 90 transfer of credits for the General Education and Foundation course requirements. +++Prior to enrollment into the RN to MSN Programs, students must provide a valid, unencumbered RN license. Upon receipt of the license, students will be awarded 45 transfer credits toward the total program requirements, resulting in a reduction in the overall length and cost of the program.

The Master of Arts in Clinical Mental Health Counseling program has a 10-quarter track and an 8-quarter track. Program length and total cost will vary based on the track selected.

Students in the Bachelor of Science in Healthcare Management may choose to take an Anatomy and Physiology course, only BIO1011 and BIO1013 satisfy the Natural Sciences requirement. Students enrolling in either course must, however, also take the related co-requisite lab courses: BIO1012 and BIO1014 respectively. Students electing this option for their Natural Sciences requirement will complete up to 184 credit hours of work for their degree, depending on their exact choice.

Students in the Bachelor of Arts in Psychology may choose to take an Anatomy and Physiology course, only BIO1011 and BIO1013 satisfy the Natural Sciences requirement. Students enrolling in either course must, however, also take the related co-requisite lab courses: BIO1012 and BIO1014 respectively. Students electing this option for their Natural Sciences requirement will complete up to 184 credit hours of work for their degree, depending on their exact choice.

Students in the PharmD/MBA program may complete the majority of the MBA credits as part of the Doctorate of Pharmacy program. The remaining credits needed to earn the Master of Business Administration will require approximately 2 quarters of coursework.

The Master of Science in Nursing with a specialization in Family Nurse Practitioner program has \$2,625 practicum evaluation fee (5 practicum courses at \$525 per course) included in the program fee estimate.

Tiered Tuition Structure

Students who persist and successfully earn academic credits in their educational programs are eligible for a reduced tuition structure that decreases the students' actual tuition*.

Associate's-level programs:

Based on the length of the associate degree program, students will receive a tuition reduction by 10% to 15%†. Students may qualify as long as they remain enrolled and participate in an eligible program of study, making them eligible for the reduced tuition within the program. Program lengths vary in the number of credits required. This reduction will occur once the following thresholds are reached:

- Students who complete greater than 45 credits will receive a 10% tuition reduction†
- Students who complete greater than 90 credits will receive a 15% tuition reduction†

All other degree programs:

Students who persist and successfully earn academic credits in their educational programs are eligible for a tiered tuition structure that decreases the students' actual tuition cost, ranging from 10%-20%†. Students may qualify as long as they remain enrolled and participate in an eligible program of study, making them eligible for the tiered tuition at different thresholds within the program. This reduction automatically occurs as students reach the following thresholds:

- Students who successfully earn greater than 25% of the credits in their program will receive a 10% tuition reduction†
- Students who successfully earn greater than 50% of the credits in their program will receive a 15% tuition reduction†.
- Students who successfully earn greater than 75% of the credits in their program will receive a 20% tuition reduction†.

Program lengths vary in the number of credits required; the tuition credit occurs once credits earned surpass the percentages above

Reductions in tuition are applied at the beginning of each term (quarter). If the percentage of earned credit above is reached after the term starts, the reduction will occur at the start of the next term. All reductions' calculations are based on the original cost per credit hour.

For the purpose of eligibility for reduced tuition, transfer of credits that are accepted by the institution into a student's specific program of study will qualify towards credits that are successfully earned. If transfer of credit is received after a term begins, the reduction will occur at the start of the next term.

* The following programs are not eligible for tiered tuition: all Nursing and Nurse Practitioner programs, Doctor of Ministry, Doctor of Pharmacy, Master of Medical Science in Anesthesia Science, Master of Science in Information Systems, Master of Science in Physician Assistant, Master of Public Health, Master of Public Administration, Master of Healthcare Administration, and all post-graduate certificate programs.

† Students utilizing partnership agreements or enrolling as a Continual Transfer Waiver will not be eligible for the reduced tuition. The students will receive the tuition reduction as outlined in the partnership agreement or transfer waiver.
